COLLECTION AND USE OF PERSONAL INFORMATION

While accessing and\or using the Website, including performing a registration procedure, creating an account, logging in to your account, purchasing products and goods and\or using any of the Website's various services, we may collect and you may provide us with certain information, including personal information.

Personal information is any information that may or can be used to directly or indirectly identify you (or any other individual), either alone or in combination with other information. Personal information also includes anonymous information that is linked to information that can be used to directly or indirectly identify you. Personal information does not include information that has been irreversibly anonymized or aggregated so that it can no longer enable us, whether in combination with other information or otherwise, to identify you.

 - When acting as a school user, we may collect your school contact information, including name, address, email address, billing address, contact person details, school logo and information about school teachers and teaching disciplines.
 - When you use our platform services, we may collect the user content uploaded by you.
- Information about payments: If you make a purchase, we (through a certified third party service provider) collect personal information in connection with the purchase. This information includes payment information, such as your credit or debit card number and other card information, which are stored in accordance with the provisions of applicable law and high quality standards by a certified third party service provider; other account and authentication information; and billing, shipping, and contact details.

Legal Basis for Processing

Our collection and processing of personal information is based on the following:

a. The need to carry out the above processing of information, which is in anticipation of entering into commercial engagements or as part of the performance of existing

- engagements with you, for example for providing you the Goods and items that you ordered through our Website.
- b. To the extent that we use the personal information for advertising or promotional activities, including direct mailing and targeted advertising, we will request your specific, freely-given, unbundled, informed and separate consent to such uses.
- c. To the extent that we use the personal information to improve this Website, services or for analyzing statistics, the basis for collection of data is our legitimate interest to conduct such improvements and analysis.

How We Use Your Personal Information

We may collect, use, store, disclose, protect or otherwise process any personal information by lawful means, in a reasonable manner and in accordance with this Privacy Policy.

Generally speaking, we may collect, use, store, disclose, protect or otherwise process any personal information by lawful means, in a reasonable manner and in accordance with this Privacy Policy. We use personal information to provide the Goods you have ordered and to further improve and develop our different products and services, to communicate with you, to offer you targeted advertisements and services, and to protect us and our users.

- **Provide customer service and answer you inquiries**: when you submit inquiries or requests with respect to the Website, services, Goods or our products, or when you contact us for such purpose. We will use such information to contact you only for the purposes for which you sent the inquiry.

Cookies are small pieces of text used to store information on web browsers. Cookies are widely used to store and receive identifiers and other information on computers, phones, and other devices. We also use other technologies, including data we store on your web browser or device, identifiers associated with your device, and other software, including web beacons and pixel tags, for similar purposes. In this Cookie Policy, we refer to all of these technologies as "cookies."

TYPES OF COOKIES
